If you have provided us with your e-mail address in the past or do so at this time we will e-mail your grain settlement sheet(s) to you unless we are instructed otherwise. Please add to your email address book the following so your settlements do not go to junk/spam email –

Please fill out the enclosed form and return it to us along with a **voided check**, not a deposit slip. A voided check is needed for the proper information to electronically deposit funds.

Once you have signed up for direct deposit, all of your **grain** payments will be direct deposited unless we are notified otherwise. **We will continue to pay only when we are notified to do so.** Please indicate on your grain ticket when you wish to be paid. Remember that requests made on grain scale tickets at the time of unload do not arrive in our office until one or two days later and tickets from the weekend do not arrive in our office until Monday for final processing. Please compensate for this when calculating when your funds will be available if you request them.

If selling out of Storage, DP, etc. prior to Noon (12:00 PM) your payment can be available in your account the next banking business day. We cannot guarantee this so please check with your financial institution to make sure the funds have been deposited. Example, if you request on Monday after Noon (12:00 PM) your deposit should be available Wednesday.
